PRIVACY POLICY

Privacy: Mastics-Moriches-Shirley Community Library, the owner of this Website, respects the privacy of users on the Internet and has developed this privacy statement to protect user privacy on its Website. The purpose of this statement is to explain the types of information WWW.COMMUNITYLIBRARY.ORG obtains about users of this Website, how the information is obtained, how it is used, how it may be disclosed to others, and how users can restrict its use or disclosure.

Personally Identifiable Information: The only personally identifiable information WWW.COMMUNITYLIBRARY.ORG obtains about individual users through our Website is information supplied voluntarily by the user. Users interacting with our site may provide WWW.COMMUNITYLIBRARY.ORG with their name, address, telephone number, email address, domain name or URL or other personally identifiable information that WWW.COMMUNITYLIBRARY.ORG may use for its own business purposes. WWW.COMMUNITYLIBRARY.ORG may share such information with its partners and agents for purposes related to WWW.COMMUNITYLIBRARY.ORG products and services, including for the purpose of contacting users about products and services that may be of interest to them. Of course, users may visit our Website without telling us who they are or revealing any personally identifiable information about themselves.

Using the Information: "Personally identifiable information" is information about you such as name, postal address, email address, company name, credit card number, birth date, social security number, etc. Generally, we may use your personally identifiable information in the following ways:

- 1. To communicate with you about your account or the Site.
- 2. To pre-populate online forms for your convenience.
- 3. To personalize various aspects of the Site.

4. To build quality and useful services by analyzing user trends and by measuring demographics and interests.

- 5. To provide you with prompt and effective customer service.
- 6. To support the operation of the Site (i.e., billing, account maintenance) and

troubleshoot.

7. To send you newsletters, promotional messages, product announcements or other communications that we feel may be of interest to you, although you may opt out of receiving these communications (see "Opting Out" below).

8. In other ways that you either expressly consent to or instruct us to undertake.

Disclosing the Information: We may disclose personally identifiable information about you to third parties without asking for explicit consent from you as follows:

1. We will perform research on our end users' demographics, interests, and behavior based on the information we collect, for example during registration, from our server log files and from user surveys. We do this to better understand and serve our users. This research is compiled and analyzed on an aggregated basis. We may share this aggregated data with current or potential advertisers, business partners, investors and other third parties interested in our business.

2. WWW.COMMUNITYLIBRARY.ORG does not sell any of your Personally Identifiable Information to third parties. However, if you have not opted out of receiving postal mail from

WWW.COMMUNITYLIBRARY.ORG or third parties,

WWW.COMMUNITYLIBRARY.ORG may rent your name postal address and phone numbers to third parties, which the third parties may use one time only to mail you information. These third parties will have no continuing right to use your name or postal address. We do not sell or rent your email addresses to third parties. All emails you receive are deployed directly by WWW.COMMUNITYLIBRARY.ORG on behalf of third parties.

3. We share web site usage information about visitors to the Site who have received a targeted email promotional campaign from us with a third-party advertising company - for the sole purpose of targeting future email campaigns and upgrading visitor information used in reporting statistics.

4. To allow third parties to provide Site features and services. These third

parties are not allowed to use personally identifiable information except for the purpose of providing these services.

5. To our contractors, consultants and professional advisors so they can provide a service to us. For example, from time to time we may use third parties to help us collect information about our users. In those cases, we will prohibit the third parties from using the information they collect for any purpose other than providing the service to us.

6. As we believe necessary to comply with the law and protect the rights, property or safety of others.

7. If you engage in illegal activity and we respond to a subpoena, warrant or other court order.

8. In connection with the sale or transfer of WWW.COMMUNITYLIBRARY.ORG or substantially all of its assets, we will share your data with the acquiring party or transferee.

9. Due to circumstances beyond our control.

Opting Out: As part of the registration process, you will supply us with your postal address, phone number, and email address, and you will be registered to receive periodic communications from WWW.COMMUNITYLIBRARY.ORG or from other reputable companies affiliated with WWW.COMMUNITYLIBRARY.ORG. If you do not wish to receive such communications from WWW.COMMUNITYLIBRARY.ORG or from the reputable companies affiliated with WWW.COMMUNITYLIBRARY.ORG, you can:

1. Opt out of receiving future emailed messages by following the "unsubscribe" instructions at the bottom of any emailed message you receive from WWW.COMMUNITYLIBRARY.ORG.

Please allow 30 days for your opt-out election to take effect. Please note that even if you opt-out of receiving the types of communications described above, we may still from time to time communicate with you about your account or operation of the Site; these communications will not be promotional in nature. For example, if our service is temporarily suspended for maintenance we might send users an email. You cannot opt-out of receiving these communications.

Non-Personally Identifiable Information: WWW.COMMUNITYLIBRARY.ORG does collect and use some non-personally identifiable, generic information about our users as a means of measuring the effectiveness of our Website. WWW.COMMUNITYLIBRARY.ORG servers identify certain user information in the normal course of operation, but such information does not reveal a user's personal identity. We collect this information only in the aggregate and use it to evaluate and improve our Website and to provide targeted information that may be of interest to users of our Website. The following are examples of non-personally identifiable generic information.

IP Addresses: An IP address is a number that is automatically assigned to a user's computer whenever that user is using the World Wide Web. Website servers can automatically identify individual computers by their IP address. WWW.COMMUNITYLIBRARY.ORG collects IP addresses for the purposes of system administration and to report aggregate information. WWW.COMMUNITYLIBRARY.ORG does not link IP addresses to any personally identifiable information.

Cookies: Cookies are pieces of information that are used for record-keeping purposes. Cookies allow WWW.COMMUNITYLIBRARY.ORG to save certain information about a user, such as a password or individual preferences, in order to facilitate and enhance the user's future activities on WWW.COMMUNITYLIBRARY.ORG Websites.

WWW.COMMUNITYLIBRARY.ORG will not use cookies to retrieve information from a user's computer other than that voluntarily supplied by the user. Except as otherwise provided in this statement,

WWW.COMMUNITYLIBRARY.ORG shall not use information transferred through cookies for any promotional or marketing purposes.

Computer Settings: Settings, technical and other information from your computer, such as your operating system, browser version, connectivity, various communication parameters and other information related to the operation and interaction of WWW.COMMUNITYLIBRARY.ORG Websites may be collected by WWW.COMMUNITYLIBRARY.ORG . Except as otherwise provided in this statement,

WWW.COMMUNITYLIBRARY.ORG will use such information solely in order to provide technically appropriate formatting of information provided by WWW.COMMUNITYLIBRARY.ORG and access to WWW.COMMUNITYLIBRARY.ORG Websites. The collection of this information will not include any personally identifiable information about you or any individual user.

Information Provided by Children: WWW.COMMUNITYLIBRARY.ORG's Websites are not targeted at children and do not collect or use any personally identifiable data from children.

Disclosure Pursuant to Legal Process: WWW.COMMUNITYLIBRARY.ORG shall, pursuant to applicable law, regulation or legal process, such as a search warrant, subpoena or court order, allow access to all available and relevant information in order to comply with such process and protect WWW.COMMUNITYLIBRARY.ORG's rights and property. WWW.COMMUNITYLIBRARY.ORG may also allow access to this information in special emergencies where physical safety is at risk.

<u>Other Websites:</u> WWW.COMMUNITYLIBRARY.ORG is committed to protecting user privacy on all WWW.COMMUNITYLIBRARY.ORG Websites and expects the same from our partners, co-sponsors, and suppliers. WWW.COMMUNITYLIBRARY.ORG, however, is not responsible for the content or the privacy practices of non-
