Introduction

Sunrise Wind LLC (Sunrise Wind or the Applicant), is proposing to construct, operate, and maintain the Sunrise Wind New York Cable Project (the Project). The Project is defined as a major electric transmission facility and is subject to review and approval by the New York Public Service Commission (NYSPSC) under Article VII of the New York Public Service Law (PSL) and the requirements of Title 16 of the New York Codes, Rules, and Regulations (NYCRR) Part 85, as it is greater than one mile in length with a design capacity of 125 kilovolts (kV) or more.

The Applicant submits this Public Involvement Plan (PIP) to the NYSPSC to establish the forum in which community residents and other stakeholders can participate in the Article VII review process.

The purpose of this PIP is to demonstrate the Applicant's commitment to robust, inclusive, and transparent public involvement, and to detail the approach to public engagement that it will utilize to: 1) identify stakeholders in the area of the proposed Project; 2) advance public understanding of the Project; 3) encourage and collect public input; and 4) disseminate information to the general public and stakeholders that are directly affected by the Project.

This PIP also takes into consideration strategies that can be deployed to address concerns related to COVID-19 and accompanying social distancing requirements. These strategies include a shifted focus towards virtual engagement through open house webinars and other online learning opportunities, an increased social media presence, and the reconsideration of practices such as door-to-door notifications.

The Article VII public information requirements are addressed in this PIP to ensure the Project meets or exceeds compliance with public information guidance. A list of stakeholders is included in Appendix A, and a list of locations where the Article VII



application will be publicly available. Importantly, extensive pre-application outreach has occurred over the months leading up to the Article VII filing, as described in Appendix B.

Applicant Description

Sunrise Wind LLC (Sunrise Wind or the Applicant) is a 50/50 joint venture between Orsted North America Inc. (Orsted NA) and Eversource Investment LLC (Eversource).

Sunrise Wind brings unparalleled experience in developing offshore wind to New Yorkers, as a 50/50 Joint Venture between Orsted NA, the global leader in offshore wind and a global leader in climate action, and Eversource, New England's largest energy company and premier electric transmission builder.

Orsted - which has recently ranked as the most sustainable company in the world and will be the world's first major energy company to become carbon-neutral by 2025 - envisions a world run entirely on green energy, while Eversource is one of the Nation's top ranked publicly-traded companies, as identified by Newsweek, Forbes and JUST Capital, and has committed to becoming carbon neutral by 2030, faster than any other utility in the US.

Orsted and Eversource will together deliver clean, reliable energy to the Northeast through offshore wind.

In December 2016, Orsted NA and Eversource entered into a 50/50 Joint Venture to develop offshore wind in the Northeast. That partnership has now grown to include at least 4,000 MW of offshore wind, including the now awarded Revolution Wind, South Fork Wind, and Sunrise Wind projects.

Project Description

The Applicant proposes to construct, operate, and maintain the Sunrise Wind New York Cable Project (the Project) as shown below in Figure 1. The Applicant executed a 25-year Offshore Wind Renewable Energy Certificate (OREC) contract related to the Sunrise Wind Farm (SRWF) and the Project with the New York State Energy Research and Development Authority (NYSERDA) in October 2019. The Project will deliver power from the SRWF, located in federal waters on the Outer Continental Shelf (OCS), to the existing electrical grid in New York. The Project includes offshore and onshore components within New York State (NYS) that are subject to PSL Article VII review and will interconnect at the existing Holbrook Substation, which is owned and operated by the Long Island Power Authority (LIPA).

Specifically, power from the SRWF will be delivered to the existing mainland electric grid via distinct transmission cable segments: the submarine segment of the export cable (SRWEC), which will be located in both federal and NYS waters (the NYS portion of the cable referred to as the SRWEC-NYS), the terrestrial underground segment of the transmission cable (Onshore Transmission Cable), the new Onshore Converter Station (OnCS-DC) and the underground segment of the interconnection cable (Onshore Interconnection Cable). The Onshore Transmission Cable, the OnCS-DC, and Onshore Interconnection Cable (collectively, the Onshore Facilities) are all located in the Town of Brookhaven, Suffolk County, New York.

The Project's components are generally defined into two categories.

SRWEC-NYS

One direct current (DC) submarine export cable bundle (320 kilovolt [kV])
 up to 6.2 miles (mi) (10 kilometers [km]) in length in NYS waters and 1,575 ft
 (480 m) located onshore (i.e., above the Mean High Water Line [MHWL], as
 defined by the United States [US] Army Corps of Engineers [USACE] [33



Code of Federal Regulations (CFR) 329]) and underground, up to the transition joint bays (TJBs);

• Onshore Facilities

- One DC underground transmission circuit (320 kV) (referred to as the Onshore Transmission Cable) up to 17.5 mi (28.17 km) in length within existing roadway right-of-way (ROW), TJBs, and concrete and/or direct buried joint bays and associated components;
- One OnCS-DC that will transform the Project voltage to 138 kV alternating current (AC);
- Two AC underground circuits (138 kV) (referred to as the Onshore Interconnection Cable) which will connect the new OnCS-DC to the existing Holbrook Substation; and,
- Fiber optic cables co-located with both the Onshore Transmission Cable and Onshore Interconnection Cable.



Project Stakeholders

This section of the PIP describes the identification and categorization of Project stakeholders, as well as outlines the communication methods that will be utilized to build awareness and understanding about the Project.

The Applicant has classified stakeholder outreach into four main categories: Local Communities; State & Federal Elected Officials, Agencies, and Native American tribes; Public Interest Organizations; and Media.

The Applicant has conducted, and will continually update, a detailed analysis of each stakeholder and category to determine their informational needs and how best to meet them through the plan below. This list will also be updated to include additional stakeholders as they are identified.

The Applicant will notify the stakeholder list of planned outreach events and to provide proof of service and may provide notice through email, postal mail, or both.

Local Communities

Among the top priorities for the Applicant is to foster positive relationships within the communities in which our Project facilities are located. To facilitate these relationships, the Applicant is conducting an ongoing outreach program to introduce the Project, provide updates on the progression of the Project, and gain feedback to develop local support. Equally important to the Applicant is the close collaboration with affected landowners as key members of the local communities along the Project's SRWEC–NYS and Onshore Facilities. A thorough and detailed notification plan has been established to maintain these relationships and will be further explained in the Public Education and Engagement Activities section of the PIP.

State and Federal Elected Officials, Agencies, and Native American Tribes

The Applicant has worked diligently to build a strong base of support among state and federal elected officials, regulatory agencies and Native American tribes, with proactive outreach occurring upon the Project selection, and continuing throughout the various stages of the Project's development and roll-out phases.

The benefits of the Project to Long Island and all NYS are vast, and it is a goal of the Applicant to provide the transparency and information to the elected officials so that they can proudly stand behind the Project in support. In addition to keeping agencies and elected officials apprised of Project developments, the Applicant regularly engages with Native American tribes to provide updates and discuss survey protocols, schedule and process for activities that may occur on or near tribal land. <u>Plan Summary</u>

The PIP details information about the Project, the ongoing identification and categorization of its stakeholders, and the engagement tools that will be utilized to build and maintain relationships with the public.

This PIP will remain as a living document, revised and updated upon feedback from the community and stakeholders, serving as a roadmap for how the Applicant will 1) engage with community stakeholders, 2) provide education and information on the Project, 3) solicit feedback, and 4) maintain open communication.

Communicating the details, benefits, and needs of the Project in an open and transparent manner through municipal and regulatory engagement is essential to the success of the Project.

The Applicant is committed to maintaining this level of transparency, as well as incorporating stakeholder feedback to the greatest extent possible.

The ability to build and sustain relationships throughout the Project, is a key measure of our overall performance and success.

This plan description details the tactics that will be utilized within the PIP, how those tactics will be adapted to meet individual stakeholder needs and how those tactics will evolve during each Project phase.



Project Phases

The Project outreach strategy is phased to allow for the focus and engagement tools to adapt to the communication needs of each phase of the Project's lifecycle. The phased outreach strategy will follow the Project throughout its lifecycle and will progress from introduction through operation. The Applicant has identified the following phases of activity: Project Introduction, Article VII Application, Environmental Management and Construction Plan (EM&CP) Development, Pre-Construction, and Construction.

Project Introduction

- o The Applicant will begin to identify a preliminary list of stakeholders, as well as strategies to identify further stakeholders as outreach efforts progress.
- During this initial phase, the Applicant will conduct a series of individual meetings and outreach efforts to begin fostering relationships within the community, educate stakeholders on the Project, and solicit feedback that can be incorporated into the detailed design of the Project when feasible.
- A key objective of these introductory meetings is identifying other stakeholders that need to be engaged by the team, while continuing to build a comprehensive stakeholder list.
- o This phase will also be used to refine tools and methodologies, shape the overall message of the Project, and host outreach efforts such as project open houses and webinars.

Article VII Application

- Draft, notice, and file Article VII application and support the Applicant moving through the Article VII process.
- During this time, the Applicant will continue to conduct outreach meetings with stakeholders, provide public notice of filings and related information, further evaluate and incorporate feedback and gather the necessary tools to prepare for the EM&CP Development Phase.

EM&CP Development

 The focus of this phase will be to further refine and adapt the tools and methodologies that will be implemented to meet requirements resulting from the Article VII Certificate of Environmental Compatibility and Public Need (CECPN).



o The Applicant will begin to develop the framework of these strategies throughout the initial phases of the Project, implementing them where applicable as a best effort. They will be updated to reflect specific conditions and requirements as they are identified in the proceeding.

Pre-Construction

- The primary focus of this phase is to ensure compliance with the Article VII
 CECPN and EM&CP approval conditions.
- During this phase, the Applicant will inform local stakeholders of anticipated activity; ensure any permit requirements are prepared for and met; and begin to implement the tools and strategies developed from the Article VII CECPN and EM&CP approval conditions.
- The Applicant will also utilize this time to conduct a series of training and educational meetings for crews that will be performing field work, setting expectations that align with the goals of both the community and the Applicant.

Construction

- o The focus of this phase will be hyper-local and specific to the area that work is occurring. The Applicant will employ all the tools that have been developed and refined throughout the earlier phases and will use them to facilitate communications focused on timeframes, current details, and work to mitigate any specific concerns that may arise.
- o This phase will also include a series of high-level updates on construction status with elected officials, local and NYS agencies, and other key stakeholders to keep them apprised of Project development and status.



Project Demographics

The Applicant has compiled a wide range of economic and social data that will be used to further increase our understanding of the communities where the Project is located. This data will allow the Applicant to develop outreach activities and messaging that is specific to a given area by identifying relative local factors. These include factors such as computer and internet access to determine the effectiveness of web-based communication; language barriers to understand what language should be available for printed and online collateral; commute time to identify which areas are most likely to be impacted by traffic management; and other general economic and social demographics.

With a complete Project footprint within Suffolk County and the Town of Brookhaven, data provided is measured against the average for NYS, Suffolk County, and each of the individual Census Tracts that are encompassed within the Project.

Please see Appendix C, Project Demographics for more information.



Language Access

Using data from the US Census Bureau American Community Survey 5-Year Estimates, the Applicant has identified prevalent language barriers that could occur within the geographical footprint of the Project. As open communication is a top priority, it is important that we can effectively communicate and relay information to all that are interested, regardless of language.

Suffolk County contains the entirety of the onshore Project footprint and, therefore, has been used as the necessary study area. Of the population, 77.3 percent of residents speak English only. Of the 22.7 percent of residents that are speakers of a primary language other than English, 8.7 percent speak English less than "very well."

At 14.2 percent, Spanish accounts for the largest portion of the primary language spoken in Suffolk County, aside from English, with 6.1 percent speaking English less than "very well."

Language data was also evaluated at an increased scope, looking at the Town of Brookhaven specifically as the entirety of the onshore route footprint falls within its boundaries. Of the population, 82.6 percent speak English only. Of the 17.4 percent of residents that are speakers of a primary language other than English, 3.2 percent speak English less than "very well."

At 8.5 percent, Spanish accounts for the largest portion of the primary language spoken in the Town of Brookhaven, aside from English, with 2 percent speaking English less than "very well."

This language data is also broken down by individual Census Tracts within the Project area which showed similar results of predominantly Spanish for primary languages spoken other than English.



In response to this data, the Applicant has determined that Spanish speaking translators will be available for any open houses. Additionally, Project collaterals for open houses and other public events will be available in English, as well as Spanish. These collaterals include any printed materials that will be available for public takeaway, such as Project factsheets and issue-specific factsheets. Members of the Applicant's team are fluent in Spanish and will be utilized when needed.

A detailed summary of languages and other project demographics is available in Appendix C.

<u>Stakeholder Consultations To-Date</u>

The Applicant has been proactively conducting stakeholder outreach meetings since Project development began in late 2018. These meetings have been held with elected officials, state, Long Island region, Town and County agencies, advocacy organizations and several other local communities' stakeholders. Discussions have ranged from general Project introductions, educational partnership and job development opportunities, and the collaborative development of both onshore and offshore cable routing.

A summary list of pre-application meetings and topics is available in Appendix B.

Public Education & Engagement Activities

To effectively communicate and engage with stakeholders and members of the public, the Applicant has developed a series of tools and methodologies that will be implemented throughout the various phases of the Project. These efforts may vary depending on current phase of the Project but range from the development of a clearly-articulated local value proposition and in-person relationship building, to comprehensive and routine status updates and robust media strategies.

The tools implemented by the Applicant will include, but are not limited to:



Stakeholder Database

- A Project public involvement database has been created to support outreach activity and communication for Project development. This database builds upon the stakeholder list and will serve as the primary distribution resource across the Project. This list includes the names and contact information for the full group of stakeholders, also including categorization, relationship leads, engagement frequency, issues and concerns and key meeting takeaways.
- This database will be maintained and constantly adapted and updated throughout the various phases of Project development.

Project Website

- The Project website has been developed and can be found at: www.sunrisewindny.com.
- o The overall objective of the Project website is to serve as a central informational hub. It will be a primary line of information distribution and will be referenced in all educational materials.
- o The website contains general information on the Project and the partnership, as well as resources such as Project factsheets, FAQ, related news and updates.
- A link for a supplier registration is included for those who are interested in participating in the supply chain.
- The website will also feature a dedicated landing page for ongoing and upcoming field work. Included activities will range from survey work through construction and will contain the full scope of work and status of that activity.
- o The website will also feature a section dedicated to public meetings and informational opportunities such as webinars or open houses, announcing



- upcoming meetings and keeping an archive of previous materials and presentations.
- A web portal is included where visitors can contact the Applicant directly at info@sunrisewindny.com.
- The website will continue to develop to meet the evolving needs of the
 Project, continually updated to adapt to each individual Project phase.

Educational Material

- A Project factsheet has been developed providing general details on the Applicant, including information on the Project, an overview of the partnership, benefits to be delivered and contact information for more information.
- Specific factsheets will also be developed throughout survey and construction phases to provide more detail on the current activity. These will be distributed to both municipal officials and abutting landowners and will include a timeline for the activity and contact information for the Applicant.
- Factsheets will also be made available on the Article VII process; including information on the process for intervenor funding, who is eligible and how to request funding, project milestones, and becoming a party.
- The Applicant will also develop factsheets to address specific issues of concern, which may include onshore cable routing construction, for example.
- Project factsheets will all be posted to the Project website, and will also be distributed through social media, email, newsletters, in-person and educational meetings and direct mail when appropriate.
- Examples of educational materials and outreach tools are available in Appendix E.



Public Open Houses & Webinars

- A series of open houses will be offered throughout the Project area, particularly in the neighborhoods that will be closest to construction activities. These open houses may be either virtual; or held in community spaces open and convenient to the public such as fire stations, schools and libraries and on days and at times schedule to maximize stakeholder's participation.
- The Applicant focused on building a COVID-19 pandemic adaptable plan that can be delivered in both in-person and virtual platforms.
- o The purpose of these open houses is to initiate and facilitate the open dialogue between the Applicant and local community stakeholders. A general Project overview and introduction will be given, highlighting the benefits, needs, and impacts that will be associated with the Project.
- Open houses will also serve to further collect stakeholder feedback so that it can be brought to the Applicant for review and consideration.
- The Applicant will also be leading a series of webinars to further serve as educational resources for the Project while maintaining social distancing.
- o If the Applicant must take a strictly virtual approach, a plan has been developed to integrate with local civic associations and municipalities and to collaborate across web-based platforms by both hosting our own, as well as participating as a guest in others. This will also serve to broaden the audience.

Stakeholder Hotline

- A toll-free local hotline has been established for the Project: (631) 629-8410
- The hotline will allow individuals to contact the Applicant for more information or to have specific questions or concerns answered. This number will be provided on all materials developed to support field activities.



- All calls placed into the Project hotline will go to a recorded voicemail, as it is a non-manned number. Voicemails are then documented and logged by the Applicant and forwarded to the appropriate team member or subject matter expert.
- o The Applicant will respond to all inquiries within 96 hours.

• Periodic Newsletter

- An informative Project newsletter will be developed and distributed to support outreach efforts and communication throughout the phases of Project development.
- The content and distribution list of the newsletter will be adapted to meet the informational needs and target audience at the time and will range from general Project highlights and milestones to detailed construction updates.
- o The newsletter will serve as a tool to keep municipal and agency officials informed of progress, educate elected officials, and engage with other community partners such as chambers and civic associations.
- The newsletter will be distributed electronically through email, highlighted through Project social media, and posted to a dedicated page on the Project website. The website will also include a link for those who wish to be added to the distribution list.

Official Notifications

o In addition to the newsletter, which will provide general information and Project updates, the Applicant will also deliver a series of official notifications. These notifications will be provided to abutting neighbors and other impacted stakeholders, intended to relay information on various activities and stages of the Project.



- Official notifications include, but are not limited to, alerting abutting neighbors of upcoming noticeable survey or construction work, the completion of a Project phase or other relevant milestones.
- Recipients of these notifications will be directed to the website, email and hotline for any additional information.
- Official notifications are typically delivered through the mail and in advance of any anticipated work, but may also be delivered through email, legal notice or press release.

• Field Support

- Abutter Notifications
 - The Applicant will provide notice to abutting landowners of any noticeable upcoming survey or construction work.
 - Notifications will be delivered to abutters 1-2 weeks in advance of the scheduled activity and are intended to inform the neighbors of the Project and outline the work that will be done as well as the timeline in which it will occur.
 - A link to the Project website, email and dedicated hotline will be provided in all abutter notification for any additional information that is desired.
 - Abutter notifications will typically be delivered through the mail. Additionally, the Applicant may incorporate door-hangers and other means of communication such as legal ads or social media campaigns when appropriate.
 - If COVID-19 related restrictions do not allow door-to-door notifications, the Applicant may either enhance mail-delivered notifications or incorporate telephone distribution.



Onsite Support

- Additional field support resources will be provided when appropriate to ensure health, safety, and environmental standards are met, and to monitor field interactions with members of the public.
- This role will be filled by the Applicant with a focus in community or stakeholder relations, project management or an expert on the activity.
- The Applicant will also provide field support in the form of outreach contact cards, which can be distributed in public interactions to direct them to the Project website, hotline, email or social media for more information. A larger sign containing the same information will also be posted on vehicles and barriers for construction exclusion zones when appropriate.
- Staffing commitments will vary depending on the specific needs of a given activity.
- If COVID-19 related restrictions impact the number of non-essential employees that may be on-site, the Applicant will increase efforts for contact-free information distribution, such as directing any interested individuals to a dedicated hotline and Project website for more information, as well as increasing the number of posted signs around the site.

• Media Relations Plan

Today all forms of media dominate the lives of most of our stakeholders, making media including digital, print, television, radio, and social media an important tool for educating the public about the Project. The Applicant intends to engage with each form of media throughout the Project's lifecycle to communicate 1) the configuration of the Project, 2) the opportunities for public engagement, and 3) the status of the Project's development efforts.



The Applicant will designate points of contact to respond to informational inquiries from print, television, digital and radio media representatives. These points of contact will be available on an on-call basis to provide timely information.

Similarly, the Applicant anticipates maintaining a Project Twitter presence (@SunriseWindNy) that can be used to disseminate information and interact with members of the public who are seeking more information about the Project.

Key topics addressed on social media amongst other outlets may include: 1) Project design and configuration, 2) public engagement opportunities, 3) the status of Project development, and 4) the health and safety precautions undertaken by the Project.



PLEASE TAKE NOTICE THAT, on or about December 9, 2020, pursuant to Article VII of the Public Service Law of the State of New York, Sunrise Wind LLC (the "Applicant"), a 50/50 joint venture between Orsted North America Inc. ("Orsted NA") and Eversource Investment LLC ("Eversource"), will file an application with the New York State Public Service Commission (the "NYSPSC") for a Certificate of Environmental Compatibility and Public Need ("Certificate") to construct, operate, and maintain the Sunrise Wind New York Cable Project (the "Project").

DESCRIPTION AND PROPOSED LOCATION OF THE PROJECT

The Applicant executed a 25-year Offshore Wind Renewable Energy Certificate ("OREC") contract related to the Sunrise Wind Farm ("SRWF") and the Project with the New York State Energy Research and Development Authority ("NYSERDA") in October 2019. The Project will deliver power from the SRWF, which will be located in federal waters on the Outer Continental Shelf ("OCS"), to the existing electrical grid in New York ("NYS"). The Project includes offshore and onshore components within NYS that are subject to Public Service Law Article VII review and will interconnect at the existing Holbrook Substation, which is owned and operated by the Long Island Power Authority ("LIPA").

The Project's electrical transmission facilities will be comprised of both onshore and offshore cable systems. Specifically, power from the SRWF will be delivered to the existing mainland electric grid in the Town of Brookhaven, Suffolk County, New York via distinct Project segments: the submarine segment of the export cable (the "SRWEC"), which will be located in both federal and NYS waters (the NYS portion of the cable is referred to as the "SRWEC-NYS"); the terrestrial underground segment of the transmission cable (the "Onshore Transmission Cable"); the new Onshore Converter Station (the "OnCS-DC"); and the underground segment of interconnection cable (the "Onshore Interconnection Cable"). The Onshore Transmission Cable, the OnCS-DC, and Onshore Interconnection Cable are all located in the Town of Brookhaven, Suffolk County.

The SRWEC-NYS is a direct current ("DC") electric cable (320 kilovolt ["kV"]) that will deliver electricity generated by the SRWF. The SRWEC enters NYS waters at a point 3 nautical miles ("nm") offshore from Fire Island and will consist of one submarine export



cable bundle up to 6.2 miles (10 kilometers ["km"]) in length in NYS waters to the landfall location on the eastern portion of Smith Point County Park on Fire Island in the Town of Brookhaven, and a segment up to 1,575 feet (480 meters) located onshore and underground up to the transition joint bays ("TJB") within the parking lot for Smith Point County Park.

The transition of the SRWEC-NYS and Onshore Transmission Cable will occur where the cables will be spliced together at co-located TJBs and link boxes that will be installed in the parking lot within Smith Point County Park. The Onshore Transmission Cable will consist of one underground DC transmission circuit (320 kV) up to 17.5 miles (28.2 km) in length that will be located within existing developed rights-of-way ("ROW") to the extent practicable in the Town of Brookhaven.

Power from the Project will be delivered to the NYS electric grid via a new OnCS–DC to be constructed in the Town of Brookhaven. The purpose of the new OnCS–DC is to support the Project's interconnection to the existing electrical grid by transforming the Project voltage to 138 kV alternating current ("AC"). Interconnection to the electric grid will occur at the existing Holbrook Substation, which is also located in the Town of Brookhaven, via the Onshore Interconnection Cable. The Onshore Interconnection Cable will consist of two underground 138 kV AC circuits, approximately 1 mile (1.6 km) in length, which will connect the new OnCS–DC to the existing Holbrook Substation. The Onshore Interconnection Cable will be located within existing roadway and utility ROWs in the Town of Brookhaven.

ACCESS TO ARTICLE VII FILING

The Applicant expects to file the Article VII application with the NYSPSC on or about December 9, 2020. PLEASE TAKE NOTICE THAT, on December 9, 2020, pursuant to Article VII of the New York Public Service Law (the "PSL"), Sunrise Wind LLC (the "Applicant"), a 50/50 joint venture between Orsted North America Inc. and Eversource Investment LLC, filed an application (the "Application") with the New York State Public Service Commission (the "NYSPSC") for a Certificate of Environmental Compatibility and Public Need ("Certificate") to construct, operate, and maintain the Sunrise Wind New York Cable Project (the "Project"). The Applicant plans to file an amendment to its Application on or about April 12, 2021 (the "Amendment"). Your property has been identified as abutting, or as being within 500 feet of, a portion of the Project's known or potential route. Since you may be impacted by the Project, you are being provided with this notice to inform you about the Project and provide you with information on how to participate in the NYPSC proceeding to consider the Application.

DESCRIPTION AND PROPOSED LOCATION OF THE PROJECT

In October 2019, the Applicant executed a 25-year Offshore Wind Renewable Energy Certificate ("OREC") contract related to the Sunrise Wind Farm ("SRWF") and the Project with the New York State Energy Research and Development Authority ("NYSERDA"). The Project is necessary to deliver the power generated by the SRWF, which will be located in federal waters on the Outer Continental Shelf ("OCS"), to New York's ("NYS") electric grid. The Project includes offshore and onshore transmission components within NYS that will interconnect at the existing Holbrook Substation, which is owned and operated by the Long Island Power Authority ("LIPA"). These transmission components are subject to NYPSC review under PSL Article VII.

Power from the SRWF will be delivered to NYS's existing electric grid in the Town of Brookhaven, Suffolk County, New York via distinct Project segments: the submarine segment of the export cable (the "SRWEC"), which will be located in both federal and NYS waters (the NYS portion of the cable is referred to as the "SRWEC–NYS"); the terrestrial underground segment of the transmission cable (the "Onshore Transmission Cable"); a new Onshore Converter Station (the "OnCS–DC"); and the underground segment of interconnection cable from the OnCS-DC to the Holbrook Substation (the "Onshore Interconnection Cable"). The Onshore Transmission Cable, the OnCS–DC, and Onshore Interconnection Cable will be located in the Town of Brookhaven, Suffolk County, as depicted on the enclosed map.

The SRWEC–NYS is a 320 kilovolt ("kV") direct current ("DC") electric transmission cable that enters NYS waters at a point 3 nautical miles offshore from Fire Island and will consist of: (A) a submarine export cable bundle up to 6.2 miles in length that splits and reaches its landfall location on the eastern portion of the Smith Point County Park; and (B) a segment up to 1,575 feet of onshore, underground electric transmission cable to reach the Project's transition joint bays ("TJBs") located within the parking lot for the Smith Point County Park.

The transition of the SRWEC-NYS and Onshore Transmission Cable will occur at the TJBs. The Onshore Transmission Cable will consist of 1 320 kV underground DC transmission circuit up to 17.5 miles in length that will be located, as described below, within existing developed roadway rights-of-way ("ROW") to the extent practicable.



From the TJB, the Onshore Transmission Cable will run parallel to Fire Island Beach Road within the paved Smith Point County Park parking lot, crossing the William Floyd Parkway to a recreational area located to the west of William Floyd Parkway. The Onshore Transmission Cable will then be routed across the intracoastal waterway in a northwest direction to a paved parking lot within the Smith Point Marina along East Concourse Drive. From here, the Onshore Transmission Cable will be routed north and east along East Concourse Drive to the intersection at William Floyd Parkway. The Onshore Transmission Cable will then extend north along William Floyd Parkway to the intersection with Surrey Circle. The Onshore Transmission Cable will be routed along Surrey Circle and will continue north along Church Road crossing under the Long Island Rail Road ("LIRR") to Mastic Boulevard. The Onshore Transmission Cable will travel west along Mastic Boulevard to the intersection with Francine Place and then turn north on Francine Place to the intersection with Montauk Highway.

The Onshore Transmission Cable will cross Montauk Highway to Revilo Avenue and will continue north along Revilo Avenue crossing Sunrise Highway and continuing north to the intersection with Victory Avenue. The Onshore Transmission Cable will continue west on Victory Avenue, crossing Carmans River, to Horseblock Road. The Onshore Transmission Cable will continue northwest along Horseblock Road to Manor Road. The Onshore Transmission Cable will turn north onto Manor Road and cross the LIRR to Long Island Avenue. The Onshore Transmission Cable will then be routed west along the Long Island Expressway ("LIE") South Service Road and continue to Waverly Avenue where it will turn south to Long Island Avenue. The Onshore Transmission Cable will then follow Long Island Avenue west to Union Avenue to the OnCS–DC.

Power from the Project will be delivered to the NYS electric grid via the OnCS–DC. The purpose of the OnCS–DC is to support the Project's interconnection to the existing electrical grid by transforming the Project's voltage from 320 kV DC to 138 kV alternating current ("AC"). In turn, interconnection to the electric grid will occur at the existing Holbrook Substation, which is also located in the Town of Brookhaven, via the Onshore Interconnection Cable will consist of 2 138 kV AC underground circuits, approximately 1 mile in length, which will connect the OnCS–DC to the existing Holbrook Substation. The Onshore Interconnection Cable will be routed west along Union Avenue from the OnCS–DC and then continue north within utility owned or controlled properties to the existing Holbrook Substation in the Town of Brookhaven.

The purpose of the funds is to allow such parties to contribute to the development of a complete record leading to an informed decision in this case and foster broad public participation.

Initial requests for funds must be filed with the Secretary (secretary@dps.ny.gov) and submitted to the assigned Administrative Law Judge, with copies to other parties to this case, using the form provided on the Department of Public Service's website. The form can be accessed by going to www.dps.ny.gov/articlevii.htm, and clicking on "Request for Intervenor Funds." Requests must fully comply with the Commission's rules, which provide, at 16 NYCRR 85-2.4(d), that an application for intervenor funding contain:

- (1) a statement of the number of persons and the nature of the interests the requesting party represents;
 - (2) a statement of the availability of funds from the resources of the requesting party and from other sources and of the efforts that have been made to obtain such funds;
 - (3) if the requesting party represents owners or occupants of real property, the location of such real property in relation to the route proposed for the facility and any alternative route specified as reasonable in the application;
 - (4) the amount of funds being sought;
 - (5) to the extent possible, the name and qualifications of each expert to be employed;
 - (6) if known, the name of any other party who may, or is intending to, employ such expert;
 - (7) a detailed statement of the services to be provided by expert witnesses, consultants or others (and the basis for the fees requested), specifying how such services will contribute to a complete record leading to an informed decision as to the appropriateness of the facility and route;
 - (8) a statement as to the result of any effort made to encourage the applicant to perform any proposed studies or evaluations and the reason it is believed that an independent study is necessary; and



(9) a copy of any contract or agreement or proposed contract or agreement with each expert witness, consultant or other person.

Applicants for intervenor funding must be parties to this case. Once the Project's Article VII application is filed, a new docket will be opened and interested persons can choose to subscribe to a service list, become a party to the case, or monitor the case via the NYSPSC website.
